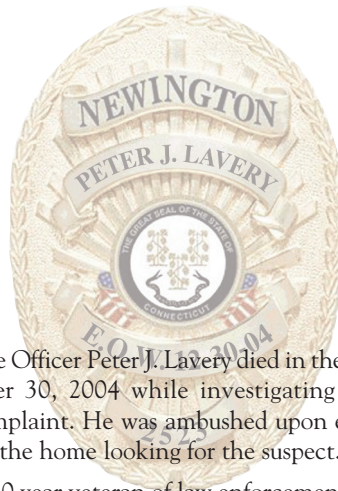

## MPO Peter J. Lavery



Master Police Officer Peter J. Lavery died in the line of duty on December 30, 2004 while investigating a domestic violence complaint. He was ambushed upon entering the basement of the home looking for the suspect.

Peter was a 20 year veteran of law enforcement and served with the Newington and Berlin Police Departments. He was a member of the Newington Police Department's Motorcycle

Patrol and represented the department at many functions including the 911 Memorial Ride to Washington D.C.

In addition to his law enforcement service, Master Police Officer Peter J. Lavery served his country for 20 years in the Connecticut National Guard. He was honorably discharged at the rank of Major. He has received numerous awards during his law enforcement and military careers.

Peter left behind a loving wife, Pamela, two beautiful children Raymond & Samantha and many other relatives, including two older brothers both of whom retired from the Newington Police Department.

The tournament was created to contribute funds to the Peter J. Lavery Memorial Scholarship Fund. This scholarship in Peter's memory will honor deserving young adults interested in pursuing a career in Law Enforcement.
